Proposal:- Proposed single storey rear extension with balcony

**Relevant Site History:-**

#### **Representations:-**

**Summary:-** This is a three storey town house which backs on to Wetherspoons' garden. The proposal is to extend across the back of the property to a depth of 5m. The shape of the applicant's garden dictates that the extension will narrow to a width of 6.6m. The extension will allow for a large kitchen diner with french doors onto the garden and what appears to be velux windows in the roof. At present the applicant has a small balcony on the first floor, little more than a Juliet balcony. It is proposed to create a balcony on the roof of the extension. The balcony will will have a powder coated aluminium frame with obsured safety glass.

**Recommendation:-** This extension would increase the floor space considerably in relation to the original size. The Design Statement states that the rear amenity space would be reduced to 87 square metres which seems a generous estimate but that the balcony could be used to bring the amount back to its original size. The balcony would be mainly overlooking Wetherspoons beer garden but there are neighbours either side. To ensure privacy of the neighbours there will be an opaque safety glass screen. In the plans it shows a height of 1.5m but in the statement as 1.8m. I do feel that this proposal is over-development of site and there is potential for over-looking. I would therefore recommend refusal on the grounds of over-development of site and potential for adverse impact on neighbouring amenities unless the height of the balcony screen is definitely 1.8m rather than that shown on the plans as 1.50m.

Dear Nikki

Thank you for your recent letter addressed to Roger Hirst, Police Fire and Crime Commissioner, regarding 20mph speed limits on residential estates.

Road Safety continues to be a priority within the Police Fire and Crime Commissioner's Police and Crime Plan and working with partners such as Safer Essex Roads Partnership (SERP), local authorities and National Highways we are tackling speeding, drink, and drug driving to improve road safety and reduce road death in Essex to zero by 2040.

Having checked with the Head of Roads Policing for Essex Police, whilst the force is always consulted prior to the introduction of any new proposal, the placing of speed limits is a matter for Essex County Council Highways. Essex County Council has an existing policy covering speed management, sitting alongside their route hierarchy strategy. Both policies are currently subject to review which we hope will bring them into line with the safer systems principles required to achieve Vision Zero. The 20mph zones are different to speed limits, as a zone will always be supported by measures such as raised tables; such designs are normally found on new housing developments. Your voice here matters so we would encourage you to share your views with Essex Highways and Essex County Council.

Community Speed Watch (CSW) is a local traffic monitoring support by SERP and partners. It is delivered by volunteers within their own communities aiming to improve road safety. Becoming part of CSW gives an opportunity for residents to increase road safety in their area, and support activities to reduce road traffic collisions and injuries. Volunteers receive full training, are provided with equipment, and supported by a CSW Co-ordinator and Essex Police. #### 20's Plenty for Essex Zoom mtg 10.12.24

Adrian Berendt from national 20's Plenty campaign talked re Wales success with 20mph reducing death and injury by nearly 30% being <u>recognised in CIHT awards</u>

Latest <u>evidence from Wales</u>, average speeds down, minimal impact on journey times. <u>20mph</u> <u>Misinformation Factsheet</u>

**Payback is quick.** Wales cost of changing the 30mph default to 20mph c. £10 p/head of population; payback within 12 months.

Aside from incalculable cost and impact of trauma for all involved, measurable cost of a fatality is £2.25 million; serious injury c.£290,000 (Cornwall CC quoted DfT figures).

For Essex, the cost of making 20mph the default would be c. £15million.

Year one, min. 20% fewer casualties.

In 2023 Total casualties 3658

With 20mph, there would be 730 fewer casualties (inc 170 Killed & Seriously Injured) saving over £75 million of public funds.

Changing the current 30mph default to 20mph across Essex communities is MUCH cheaper than piecemeal delivery of 20mph 'zones', individual streets, just on estates or around schools - which simply can't bring the multiple benefits of a much safer street network: less death and injury, more cycling and walking, reduced pollution and noise and substantially improved community liveability. <u>Vision Zero</u> is failing and will continue to do so without 20mph being the norm where people and traffic mix and interact.

Essex Police report March 2024

5.17. The number of people killed or seriously injured is not declining and remains above the target line for reducing death and serious injuries by 50% ahead of 2030, which in turn sets the trajectory for zero death and serious injury by 2040. Motorcyclists, young drivers, including passengers, and pedestrians remain the most at risk road user groups.

Devolution speculation brings uncertainty about the May election, but for now we need to proceed as if it's going ahead.

<u>May 2025 ECC election</u>: We're urging residents, councils and organisations to contact our political groups ASAP asking for an election pledge to make 20mph the default across Essex where communities want it.
