Officer Report: Member's Expenses Review

#### **Current Expense Arrangements:**

- Each year, the Town Council currently sets aside a fixed reserve of £3,600 for Member's Expenses, equating to a £200 allowance for each Member. This allowance remains largely unclaimed each year.
- For financial year 2019/20, Braintree District Council's total expenditure on Member's allowances was £433,653.58, with a basic annual allowance of £4,899.51 afforded to each District Councillor.

#### **Review Proposals**

- As the Council's business and ambitions continue to grow, all Members now have to attend a record level of committee meetings and handle more officer correspondence. In addition, a growing number of events requires additional support from Members.
- There is a high risk that Members of the Council are left "out of pocket" by virtue of being elected and incurring travel and event costs, but also administrative costs associated with handling office correspondence and papers.
- Members are asked to consider an overhaul of the Member's expenses reserve into a routine budget line of the Policy & Resources Committee, and to increase the total value of the fund from £3,600.00 to £8,000.00, creating a £500.00 annual allowance for each Member of the Council.
- If approved, the uplift in allowance would take place on 1<sup>st</sup> April 2022, with details published online in accordance with the Transparency Code for Smaller Authorities.

#### Advice:

- To consider the appetite for overhauling the Member Expenses arrangements.
- Members may also wish to consider the role allowances play in ensuring the Town Council remains a viable prospect for future electoral candidates.

Officer Report: Treasury & Investments Review

**Issue:** Witham Town Council have £221,710.03 in a 32 day notice account with Lloyds Bank with a variable AER of the Bank of England Base Rate minus 0.07%. This currently equates to 0.03% AER (Average Equivalent Rate) and provides the council with 18p a day interest.

At the Policy and Resources meeting held on 14.06.2021 members resolved that 'the Town Clerk be asked to investigate options in regard to balances and if necessary the Council's Treasury and Investment Policy be reviewed'. The current Treasury and Investment Policy is written in accordance with 'Statutory Guidance On Local Government Investments (3rd Edition) Issued under section 15(1)(a) of the Local Government Act 2003. The policy currently states that investments are made only with banks and building societies with 'High Credit Quality', that they are UK registered institutions and deposits are for no longer than a fixed term of 12 months.

It was suggested that officers consider CCLA Investment Management Ltd who manage a Public Sector Deposit Fund recommended by several other Parish and Town Councils.

CCLA Investment Management Ltd are a UK registered institution but as of August 2021, 60-70% of their exposure is with banks domiciled outside of the UK although these institutions credit ratings are comparable with those of Lloyds Bank. Due to market fluctuations the yield changes daily but at the time of writing it is only 0.0236% for their instant access account.

The Statutory Guidance On Local Government Investments states that 'when entering into treasury management investments, local authorities should consider security, liquidity and yield in that order of importance. Once proper levels of security and liquidity are determined, it will then be reasonable to consider what yield can be obtained consistent with these priorities'.

Lloyds Bank are offering as a variable deposit 0.05% AER with a 95 day notice period (Bank of England Base Rate minus 0.05%) which would increase the interest received by the council without increasing the risk and minimally affecting liquidity.

The council's Unity Current Account has £348,916.12 with the second instalment of the precept due to be received by the Council during September. Members might consider moving extra funds from Unity Bank into the current Lloyds Bank account although the Financial Services Compensation Scheme does not protect deposits from a public authority unless it has an annual budget of below EUR 500,000.00 so to minimise risk the amount held on deposit could be split between more than one institution.

Below are the current credit ratings for Lloyds bank whom the council currently invest with and another high street bank, HSBC UK Ltd for comparison.

The current Treasury Policy states that investments should not exceed a term of 12 months so staying within those parameters-

- HSBC do not provide notice accounts but would accept fixed deposits for 0.01% up to six months and 0.07% fixed for one year.
- Lloyds Bank are currently offering 0.01% for up to 3 months fixed deposit, 0.02 for 6 months fixed deposit and 0.05 for one year fixed deposit.

Interest rates are higher the longer the money is fixed for as on the 4<sup>th</sup> August 2021 the Bank of England stated that with inflation forecast to hit 4% a small increase in interest rates might be needed next year to help control inflation. Although the yield would increase when investing in longer term deposits it is important to remember that with several large projects in the current business plan funds must be accessible.

#### Advice:

That the funds currently on deposit with Lloyds on a 32 day notice period are changed to a 95 day notice period and that £150,000.00 is taken from the Unity Current Account and placed in this Lloyds account or with another institution with similar credit ratings to minimise risk.

That the current Treasury and Investment Policy as adopted on 04.05.2021 remain unchanged as with interest rates so low the risks of changing the policy to allow investments with other organisations or for longer periods of time outweighs any benefits.

Local auditor reporting on local government in England Contents

#### Summary

Without urgent action from government, the audit system for local authorities in England may soon reach breaking point. With approximately £100 billion of local government spending requiring audit each year, the Ministry of Housing, Communities & Local Government (the Department) has become increasingly complacent in its oversight of a local audit market now entirely reliant upon only eight firms, two of which are responsible for up to 70% of local authority audits. This has not been helped by the growing complexity of local authority accounts, with audit firms now asked to carry out more work in each audit, comply with new regulatory demands and adapt to the new multifaceted landscape in which local authorities operate, while also struggling to hire and retain experienced auditors. Such problems have been evident since 2018, but the COVID-19 pandemic has heightened them with less than half of local authorities completing their audits on time in 2019–20, while more than half of the audits examined by the Financial Reporting Council (FRC) needed improvement. If local authorities are to effectively recover from the pandemic, it is critical that citizens have the necessary assurances that their finances are in order and being managed in the correct

The government-commissioned Redmond review of local government accounts and audits reported in September 2020. On 19 May 2021, the Department issued an update on its response to Redmond's recommendations and its now preferred option for a system leader. The need for system leadership for local public audit, identified by Redmond, is pressing. But the government's announced option that the future Auditing, Reporting and Governance Authority (ARGA) will become the new system leader, will take time to establish. The Authority will not be set up until 2023, at the earliest, and will require legislation. Until then, it remains unknown whether this option will be able to fully address the current failings in the market for auditing local authorities. In the meantime, the Department has much more to do to provide credible details on the practical and concrete steps it intends to take to address the urgent problems that cannot wait for ARGA. We will track progress closely for assurance that when the new system leader arrangements are operating, the local audit market will still be in place.
