261. APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillors Hicks, Jay and Pleasance.

RESOLVED That the apologies be received and approved.

262. MINUTES

RESOLVED That the Minutes of the Meeting of the Planning and Transport Committee held 6th March 2023 be confirmed as a true record and signed by the Chairman.

263. INTERESTS

All members present declared a non-pecuniary interest, in regards to applications 23/00529/TPO and 23/00530/TPOCON, as they all knew the applicants.

Councillor Goodman declared an NPI at application 23/00581/HH, as the applicant was a neighbour and Councillor Kilmartin declared an NPI at application 23/00497/HH, as she knew the applicant.

264. QUESTIONS AND STATEMENTS FROM THE PUBLIC

The member of public present did not wish to speak.

265. PLANNING OFFICER'S REPORT

The Planning Officer explained that officers had met with Andy Goodwin of National Highways to discuss issues relating to the A12 widening. It looked promising that an alternate piece of replacement land would be offered to the Town Council rather than the section to the north, divorced from Whetmead. He also explained that the footbridge over the A12 close to Olivers Drive had been contained in the plans since June 2021 and formed part of the consultations. Unfortunately, it was now too late to change its location and by doing so other residents would be affected. Notes from the Meeting would be available in due course.

The Cycling Development Group had a Teams Meeting last Friday with Braintree District Council and its consultants WSP who would be drawing up a Local Cycling and Walking Infrastructure Plan.

An application had been made by Bellway regarding the discharge of reserved conditions for boundary treatment at Gimsons. The Planning Officer had asked that the matter of railings be flagged up.

The Town Council had been contacted by Bellway regarding a meeting to discuss major investment in infrastructure and community-wide facilities. The Planning Officer advised that because of the local elections and purdah, this meeting should not form part of a Committee Meeting.

Finally, information had been received that the application to demolish an existing warehouse and the erection of a new one at 9 Stepfield would be considered by the District Council's Planning Committee on 28th March 2023. This Committee had recommended the application for approval so it was thought unnecessary that a Member attend.

Details of parking restrictions in relation to the new pedestrian crossing in Cressing Road were received.

RESOLVED That the details be received and noted.

272. PARKING OUTSIDE HOLY FAMILY SCHOOL

The Planning Officer explained that she had approached the North Essex Parking Partnership but been informed that the cameras had just been allocated to new static sites and would not be moved for about six months. She had asked for additional patrols at Holy Family School and had spoken to Essex County Councillor Louis about the situation. He had driven to not only Holy Family School but Howbridge and Chipping Hill Schools and agreed that the parking and traffic was horrendous. The Planning Officer had asked what further action could be taken to alleviate the situation and Councillor Louis said that a North Essex Parking Partnership representative would be at the next Local Highways Panel Meeting and he would ask that patrols be undertaken by the TruCam vehicle which would photograph those vehicles which were parking on double yellow lines and zig zag markings and fines issued.

RESOLVED That the information be received and the Holy Family School be informed that the cameras were not available.

273. BUS FARE INCREASES

Members were informed of the bus fare increases on Essex County Council services from 1st April 2023.

RESOLVED That the details be received and noted and that items regarding buses be referred to the Community Committee in future.

274. HGV ROUTING

Members were asked to consider appropriate routing around Witham for HGVs.

Members received a map of example routes and discussed at length potential routes for HGVs in Witham. They reiterated that Chipping Hill bridge should be avoided where possible and that clear concise signage would be required.

RESOLVED That the example map would be sent to members, so that they could send any amendments or recommendations to the office.

There being no further business the Chairman closed the Meeting at 7:29p.m.
